Direct Debit to bank account or credit card account as stated above shall be effective on the date signing of letter and shall continue in full force until the bank or credit card issuer terminates the service under the letter or I revoke and notify the bank or credit card issuer and True Group in writing of no less than 2 (two) months.

I certify that my signature in this letter of consent is the same as given to the bank or credit card issuer, therefore, when the bank or credit card issuer has already debited from my bank account or credit card account, it shall be deemed that the bank and credit card issuer has the right to debit from my bank account or credit card account.
